

**Test Request**

The sample supplied is a PVC coated fabric and has been tested to BS 5852:2006 Clause 11 using Ignition Source 5.

**Fibre Identification**

Reputed Fibre Composition: Unknown

**Pre-Treatment:**

The sample supplied was water soaked and dry in accordance to BS 5852:2006 Annex E

**Conditioning:**

Before testing the sample was conditioned in an indoor ambient condition for 72 hours and in a standard atmosphere having a temperature of 20°C ± 5°C and a relative humidity of 50% r.h ± 20% for a minimum of 16hours.

**Comments on Test Results**

The sample supplied meets the requirements of BS 5852:2006 Clause 11, NI/5.

Pass Criteria: ~ Disregard flaming which ceases within 10 minutes. Smoke, heat or glowing which ceases within 60 minutes of igniting the crib.

No smouldering is to be present in the final examination.
